





This week's Spokane Valley City Council meeting began with an invocation, the pledge of allegiance and approval of the agenda.

# **General Public Comments**

Each week, community members have an opportunity to address Councilmembers for up to three minutes during the General Public Comment period, either at the beginning or end of each meeting in person or via Zoom.

# **ACTION ITEMS**

# #1 Consent Agenda

The Council unanimously approved the consent agenda, which included vouchers for paying city expenses and payroll.

# #2 Ordinance 24-17 First Reading CTA-2024-0001 SVMC 17.80 Permit Procedures

The Council received a report on this topic on Nov. 26, 2024. This proposed ordinance will update the city code to be consistent with RCW 36.70B, adopted in April 2023, which was implemented to streamline project review for land use project permits. Staff provided an overview of the general permit process, as well as a summary of the required changes for consistency with state law. On Oct. 24, 2024, the Planning Commission voted 4-0 (3 members were absent) to recommend approval of CTA-0001 with minor wording changes, which were included in the packet. The Council reached consensus to bring this item back for a second reading.

# **NON-ACTION ITEMS**

#3 Ordinance 24-018: Amending SVMC Chapters 7.05, 19.65 and 19.160, con-

outlined six key provisions of the proposed amendment. The Council reached a consensus for this item to be brought back for an ordinance first reading

# #5 Potential Grant Opportunity: Association of Washington Cities (AWC) Energy Audit Grant

Staff shared information about a grant opportunity from AWC for cities seeking full or partial funding for building energy audits of city-owned Tier 1 and Tier 2 buildings to become compliant with the recently enacted Washington State Clean Building Law. In Spokane Valley, these are City Hall, CenterPlace and the Police Precinct. This grant requires no local match, and applications are due Jan. 31, 2025. The Council reached a consensus for staff to continue working on a grant application. On Dec. 17, 2024, the Council will be asked to approve submitting the application to AWC.

# #6 Solid Waste Transfer, Transport and Disposal Agreement with Sunshine Recyclers, Inc.

In 2014, the Council approved a 10-year agreement with Sunshine Recyclers Inc. to manage solid waste services within the city, which expires at the end of this year. On July 23, 2024, the Council selected Sunshine Recyclers for a 20-year contract to provide solid waste services and authorized staff to negotiate a final agreement for Council approval. Staff outlined key terms of the proposed contract including rates, administrative/maintenance fees, rate adjustments, designated haulers, customer service, etc. There was discussion about uses of the administrative/ maintenance fees; some uses include administration and management of the solid waste agreement, impacts of solid waste trucks on city streets, costs for publishing announcements, educational campaigns, etc. The Council reached consensus to bring the proposed agreement back at a future meeting for a motion consideration.

# cerning Camping on Private Property

Councilmembers discussed this topic multiple times in 2021-2022 but did not take any action. On Nov. 19, 2024, the Council approved amendments to the SVMC regarding camping on city-owned property. As directed by the Council, staff developed draft modifications to the code to regulate camping on private property, which would generally prohibit camping on private property with four significant exceptions. The Council reached consensus to place this item on a future agenda for an ordinance first reading.

# #4 Proposed Amendments to SVMC 3.49 to Authorize Surplus Land to be Donated for Affordable Housing and Codify Grant Award Process

State law allows cities to donate, grant or sell city-owned real estate for a less than fair market value if the property will be used for a public benefit, primarily affordable housing. However, the state law requires that cities must have municipal codes in place to "enact rules to regulate the disposition of property for public benefit purposes"; SVMC code does not currently include these rules. Staff

The wintry mix that has been falling off and on throughout the region has made it difficult for anglers to plan for a day outside. There are many though that ignore the weather, gear up and get out there no matter what Mother Nature throws at them. They are meeting with a range of success.

When I want to check on what's going on with anglers in Okanogan County, I contact Jack in the fishing department at North 40 Outfitters. This store is a popular spot for fishermen, who stop by to resupply and share their experiences with Jack. Although angling is at a low ebb with the cold and

wet weather, there are some bright spots. One of the best places to cast a line right now is at Omak Lake. According to Jack, there are three fly fishers that are fishing from Nicholson Beach, known as Beer Can Beach, and are fishing here about every other day. So, fishing must be worthwhile. He also mentioned that anglers are casting spoons from this same beach with success. The Lahontan cutthroat that inhabit Omak Lake often grab these lures on the drop. Cutts of 3 or 4 pounds are common here. I want to remind anglers who

may want to try fishing from the shore at Omak Lake that a Colville Tribal Fishing License and an Access Permit are required. You can visit the tribal Fish and Wildlife page on their website (www.cct-fnw) to learn the costs and even acquire what you need online. Rufus Woods has been quiet so far this winter for triploid rainbow trout, but anglers using jigs are getting walleye on the Nespelem Bar. Jack shared that if you are planning to fish Brandts Landing on Rufus Woods, there better be some current. If there is no flow, fishing is slow at Brandts. The last time I checked with my buddy Dave, who is a fish checker with the Colville Tribe, and patrols from Chief Joseph Dam to Brandts Landing, fishing hasn't been great yet this winter, with mostly smaller trout being landed.

There are several options available to anglers in our area. Steelhead fishing has slowed down on the Methow and the main stem Columbia River, but there are some dandy fish being landed. I just had to share a photo of a terrific hatchery steelhead that my brother Rick got on a recent trip to Pateros on my Facebook page. You may not get big numbers of steelhead, but you might get a whopper like his. I also hear that there are good numbers of kokanee being landed on Lake Chelan. This is actually a good time of year to look for kokanee on the lake. Ever since anglers realized that kokanee can be caught in the winter, there are pretty fair numbers of them out there and they have pretty good success through



ley Lake. Registration can be done online through the Oroville Washington Chamber of Commerce website. Also, you can register at the event starting at 7 a.m. and the derby starts at eight and runs through one. There is a wonderful breakfast served at the Molson Grange Hall, and a lunch provided by Sitzmark. Hot chocolate will be available right on the lake while you're fishing. Thanks to a functioning aerator on the lake, fishing has vastly improved the past few years, and the size of the trout is impressive now, and last year's winner caught both a rainbow and cutthroat. The festival is sponsored by the Oroville Chamber and proceeds benefit

> the local community. This is truly a very fun event that the whole family can enjoy.

Like many anglers here in Central Washington, I was thrilled to see the steelhead season open after a nine-year closure. I have made several trips; the first one was to Wells Dam. This was for many years my go-to spot for steelhead. I spent several seasons back trolling below the dam, off the long bar, with divers and shrimp, and had great success.

Then I discovered the fun of fishing with a bobber and jig. I learned how to pace my drift to keep a straight line to my bobber and how far to put the boat from the shore and many other things that come into play when fishing from a boat here. I had many great days and caught a bunch of great fish. My first trip to Wells on the opening day of the season this year was a bust. My buddy Rollie Schmitten and I didn't catch any steelhead on our bobber and jig set ups. Rollie remembers the first time I took him to Wells for steelhead and we were busy hooking fish. I look forward to giving Wells another try this season. On one trip this year I hooked a big steelhead that jumped in front of the boat before my line broke!

I plan on making a road trip to check on a few locations in Grant County in the coming week, and I will let you know what I learn.

# WHEN WEATHER **BECOMES THE DECIDING FACTOR**



Out-of-area-buyers often only look at property during seasons of the year when there are not adverse weather conditions. Knowing how weather might affect a certain property or certain types of structures could be a vital deciding factor. Since there are many micro-climates in our region, there should be much research done and information gathered before making the decision to purchase.

In my area, which is an extreme snow belt, many folks from warmer regions have come and gone, usually only lasting one winter before deciding that it just isn't for them. If you have the fortitude to handle areas that accumulate such snow levels, then care should be taken to look for proper construction methods that not only can physically handle the snow loads and other weather related issues, but also have styles that allow less impact when conditions are adverse, such as covered porches and metal roofs that slide away from doors and driveways.

Manufactured Homes typically have a sticker inside the home (kitchen cabinet or electrical panel) that indicates what the insulation factor is, along with the engineered roof load and whether it is sufficient for the area you live in. How is the road getting in and out? It may be fine now, but just wait until February or March! Does the road have steep grades, shaded areas, or narrow passages? Who maintains the road? Is there a written road maintenance agreement? Is there flooding in the spring and is the runoff properly ditched?

Some years ago while viewing a manufactured home that I was attempting to list for sale, I noticed that there were exposed pipes underneath the home that were not insulated and were exposed to the elements. Upon further investigation I noticed that the pump house was also un-insulated but that there was a tiny wood stove installed which I assumed had been there from past attempts to thaw out frozen pipes or to keep them from freezing. Some inexperienced buyers may overlook situations like this until they find out the hard way!

When looking for your next home in the country, choose a local real estate expert who will be aware of the factors involved in owning rural properties in all seasons of the year, not just in the summer time when most folks look.

# HORDEMANN DEER PARK DRAG STRIP BOOK SALES BENEFIT **HOSPICE OF SPOKANE**

SPOKANE – Garv Hordemann has a win-win proposition for you.

The retired college professor of mechanical engineering, historian and publisher wants to provide fans of both the Deer Park Drag Strip, and local history in general is promoting sales of his four books with Hospice of Spokane the benefactor.

Hordemann has painstakingly chronicled a special time in area motorsports history with a trio of books on the venerable Deer Park track that was located on a portion of the former World War II air base north of Spokane.

He was inspired by a former volunteer at the Deer Park track – Dave Gurr – who began writing his own book but passed away before being able to complete the effort.

The first book in the Deer Park series was titled: "A History of the Deer Park Drag Strip and Its Racers As Reported in Press Clippings: 1944-1964."

In describing the book, Hordemann writes, "It contains a collection of annotated images of several hundred clippings from newspapers, Drag News, NHRA National Dragster, Hot Rod Magazine, and other publications that reported on drag racing activities through 1964, primarily at the Deer Park Drag Strip.'

And he adds, "Clippings involving the activities of Spokane individuals at other drag strips and at the Bonneville Salt Flats are also included, as are images of memorabilia, such as pit passes, timing slips, etc."

"These latter items, interesting in themselves are often useful in shedding light on events. All items are organized according to the years in which they appeared."

This 328-page, 8.5 x 11 inch book is available only from Hordemann for \$20 or \$25 if mailed.

Hordemann's second book, published in 2021, is a two-volume, 600-page, 8 x 10.5 inch history of Deer Park drag racing. Its title is: "Deer Park Sunny Summer Days." It is the story of long ago sunny summer days of drag racing, Hordemann suggests.

The story opens in the latter years of World War II when the United States Army Air Force built what became the Deer Park Airport, and for thousands of youthful car enthusiasts, the Deer Park Drag Strip. The story ends with 1964, the year that has been called the sport's "Golden Year." An Epilogue summarizes the racing activities through 1974 when drag racing ended at Deer Park. The cost is \$60 or \$70 if mailed.

Hordemann's third book takes the best of the first two, combines and refines them. deleted. The good stories, found mostly in the two-volume book's notes, have been integrated into the main text."

Hordemann adds, "A great many of the photos have been enlarged, necessitating an addition of roughly 100 pages and a number of new photos. Many of the best photos found in Volume 2 have been moved to the main text. All of the text has been updated. The resulting book is a large single volume of 440 pages, measuring 8 x 10.5 inches."

A fourth book takes an abrupt turn from Hordemann's passion for the story of the Deer Park Drag Strip.

In "Stories My Brother Told Me," are 55 stories told by a funny, insightful, sarcastic, profane and compulsive storyteller, brother Jack Hordemann. Edited by Gary Hordemann, they are illuminated and accented by 91 illustrations, of which nearly half (41) are sketches by Jack's daughter, artist Clair Hordemann Pimley.


The tales have been arranged to follow the chronology of Jack's life, Gary Hordemann writes. They begin with an account of his baptism and end with stories about the last years of his life.

They tell of Jack's early years growing up on an Idaho farm, continue through his childhood and adult years in Spokane. Also includes several stories about his service at a remote radar station in Alaska during the Korean War.
